Frequently Asked Questions

What happens if a compliant Vendormate badge is not generated for the vendor representative?

Scrubs will not be dispensed. Rules can be set to determine grace periods or escalation, but when the time is right for your program, we recommend a "no badge, no scrubs" policy for accessing your hospital's sensitive and secure procedural areas.

What happens if a vendor is not registered with Vendormate?

The vendor must have an active registration with Vendormate and RepScrubs for scrubs to be dispensed*. Your facility's registration and badge rules should govern the access of vendors.

Is there a cost for this integration?

No, there is no additional cost to either you or vendor representatives for this integration. There are required subscription fees that will apply for both Vendormate and RepScrubs customers.

How do I prepare vendor reps for this integration?

GHX and RepScrubs will alert impacted vendor representatives of the required steps, but content can also be shared with your health system as needed.

*Vendor representatives will be required to link their active Vendormate and RepScrubs accounts.
